TRANSFER PROCEDURES

Upon transferring this Contract you must contact the Administrator and submit the following:

- Complete this form requesting that we transfer this Contract to the new owner.
- A transfer fee of \$50 must accompany this form (may vary according to state requirements).
- A copy of documentation evidencing change of ownership and mileage at time of sale.

TRANSFER CONDITIONS

- This Contract cannot be transferred to another vehicle. It can only be transferred to a different owner of the same vehicle.
- The vehicle is subject to inspection.
- Transfer must take place within 15 days of change of ownership.
- All remaining underlying warranties must be transferred to the new owner. In the event those underlying factory warranties cannot be transferred, the service contract will not cover failures to any component that would normally be covered by those warranties until the original factory warranty period has expired.
- Written evidence verifying all maintenance requirements have been met.
- The contract may not be transferred to a vehicle dealer or to the customer of a vehicle dealer.
- Contracts on leased vehicles cannot be transferred, unless the vehicle is being purchased by original lessee.

As the new owner of the vehicle, I agree to perform all maintenance services to the covered vehicle in accordance with the vehicle manufacturer's recommended periodic maintenance schedule which I understand is required per the terms and conditions defined in the Limited Warranty and/or Vehicle Service Contract I am asking to be transferred to me. **I also agree to keep all receipts of such service. I understand that it is my responsibility to obtain verifiable maintenance receipts from the original owner (Transferor) sufficient to show all manufacturer's recommended maintenance services have been performed since the inception of the Limited Warranty and/or Vehicle Service contract prior to my purchase of the vehicle. I understand that failure to provide verifiable maintenance receipts to the service contract administrator when asked, showing date and mileage of the services performed since the start date of the Limited Warranty and/or Vehicle Service Contract, could result in the denial of my claim.**
